





# PA SCHOOL CODE SECTION 780

In the event of a permanent closing of a public school or substantially all of a school's facilities, the board of school directors shall hold a public hearing on the question not less than three months prior to the decision of the board relating to the closing of the school. Notice of the hearing shall be given in a newspaper of general circulation in the school district at least 15 days prior to the date of such hearings.



# PA SCHOOL CODE SECTION 1311

a) The board of school directors of any school district may, on account of the small number of pupils in attendance, or the condition of the then existing school building, or for the purpose of better graduation and classification, or other reasons, close any one or more of the public schools in its district...

# THE HISTORY OF THE THE PENN CAMBRIA PRE-PRIMARY SCHOOL

- Original structure built in 1978
- I story wing was expanded in 1993 for district administration/IT
- Roofing dates to 2002
- All other items are original including exterior finishes, interior finishes, flooring, lighting, and heating

### **2023 FEASIBILITY STUDY**

Recommended Repairs/Updates Included:

- Underground Sanitary as Needed (\$270,000)
- Building Control System (\$267,000)
- Unit Ventilators or Upgrade to Alternative HVAC System (\$227,000)
- Receptacles and Wiring
- Plumbing Fixtures
- Electrical Panel Boards
- Add Receptacles to Classrooms
- Upgrade Telecom Wiring







# UPGRADES OF \$3,010,000

The feasibility study identified over 3 million dollars in recommended repairs or upgrades to MEP (mechanical, electrical, plumbing).

Interior and exterior finishes are not included in this number.



### DISTRICT FACILITIES FEASIBILITY STUDY

- Independent research conducted by CORE Architects
- Meetings with various stakeholders
- A variety of statistically significant data and options are considered by the board
- Decision is being considered by the board to transition to less buildings
- Common theme from stakeholders was to decrease the amount of transitions for students and increase operational efficiency

### IF WE MAINTAIN THE CURRENT BUILDING/DESIGN

- \$3 million in necessary updates to Mechanical, Electrical, Plumbing
- \$25,000 is high priority
- ESTIMATED yearly
  OPERATIONAL costs/savings
  is \$14,900
