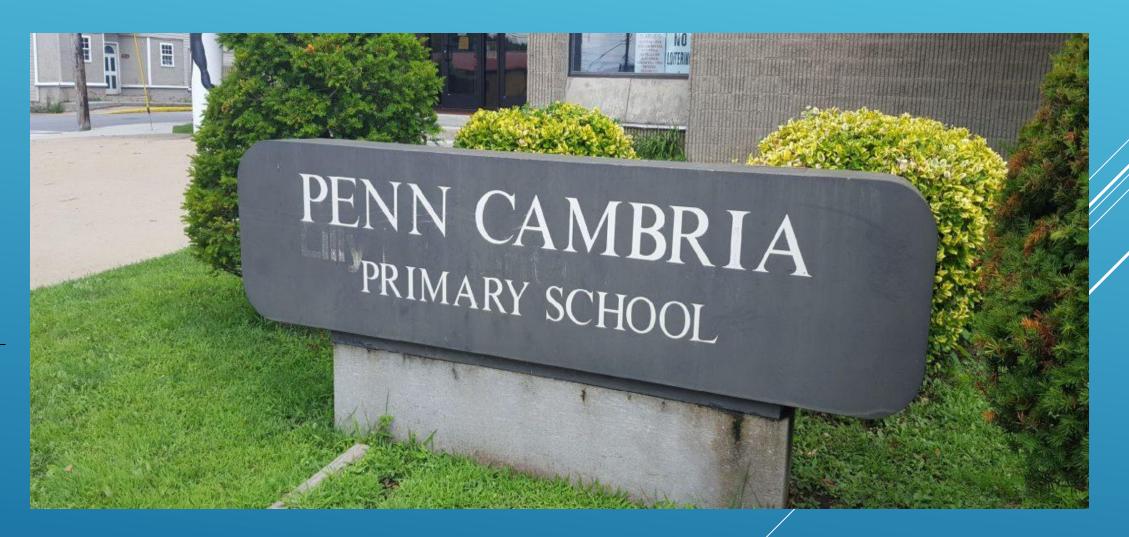

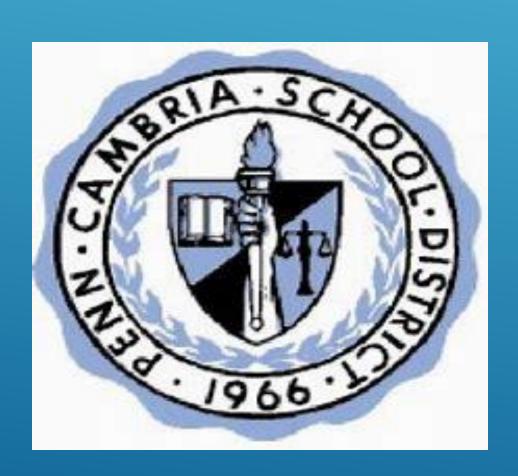

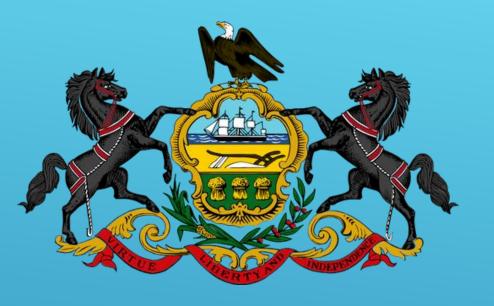


# 780 HEARING PROCESS



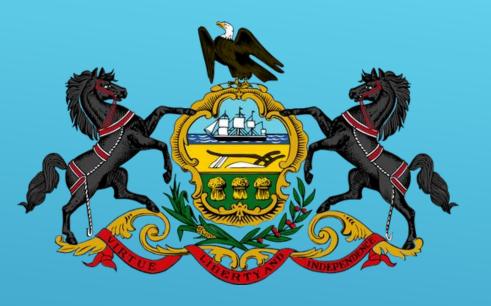
Tonight's meeting is a public hearing to share information regarding the future of The Penn Cambria Primary School and provide opportunities for public comment regarding this topic.

- Board President comments will open the Public Hearing.
- The District will then present information about The Penn Cambria Primary School.
- Anyone wishing to speak after the presentation will have the opportunity. This public comment period will operate in the same fashion as the District handles its public board meetings. Please hold all comments until the scheduled public comment session.
- You may also submit a public comment on our website if you feel you would rather not speak at the public meeting.
- A court stenographer will keep minutes of this meeting.
- After the Public Hearing, the earliest the Board can vote on the status of The Penn Cambria Primary School is November 16, 2024.



### PA SCHOOL CODE SECTION 780

In the event of a permanent closing of a public school or substantially all of a school's facilities, the board of school directors shall hold a public hearing on the question not less than three months prior to the decision of the board relating to the closing of the school. Notice of the hearing shall be given in a newspaper of general circulation in the school district at least 15 days prior to the date of such hearings.



### PA SCHOOL CODE SECTION 1311

a) The board of school directors of any school district may, on account of the small number of pupils in attendance, or the condition of the then existing school building, or for the purpose of better graduation and classification, or other reasons, close any one or more of the public schools in its district...

# THE HISTORY OF THE Penn Cambria Primary

(Originally Lilly Elementary School - 1977)



- 16 classrooms in a 3-story structure
- 1977-1994: Elementary students from the communities of Lilly and Washington Township
- 1994-Present: Several grade structures (1st 2nd), (2nd 3rd)

# THE HISTORY OF THE THE PENN CAMBRIA PRIMARY SCHOOL

- Original structure built in 1977
- Office renovation for secure vestibule
- All other items are original including roof, exterior finishes, interior finishes, flooring, lighting, and heating

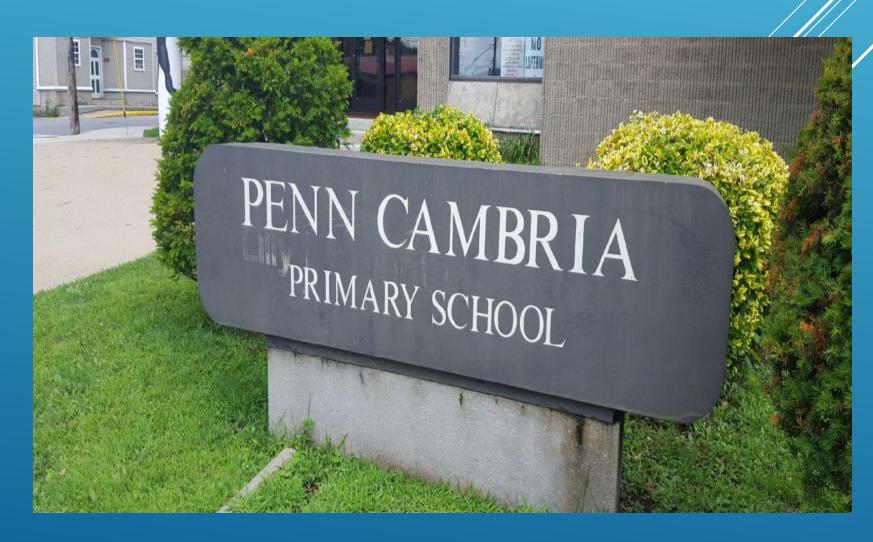

### 2023 FEASIBILITY STUDY

  - HVAC System (\$205,000)
- Receptacles and Wiring
- Plumbing Fixtures
- Electrical Panel Boards
- Add Receptacles to Classrooms
- Upgrade Telecom Wiring



### UPGRADES OF \$3,300,000

The feasibility study identified over 3 million dollars in recommended repairs or upgrades to MEP (mechanical, electrical, plumbing). Interior and exterior finishes not included in this number.



## DISTRICT FACILITIES FEASIBILITY STUDY

- Independent research conducted by CORE Architects
- Meetings with various stakeholders
- A variety of statistically significant data and options are considered by the board
- Decision is being considered by the board to transition to less buildings
- Common theme from stakeholders was to decrease the amount of transitions for students and increase operational efficiency



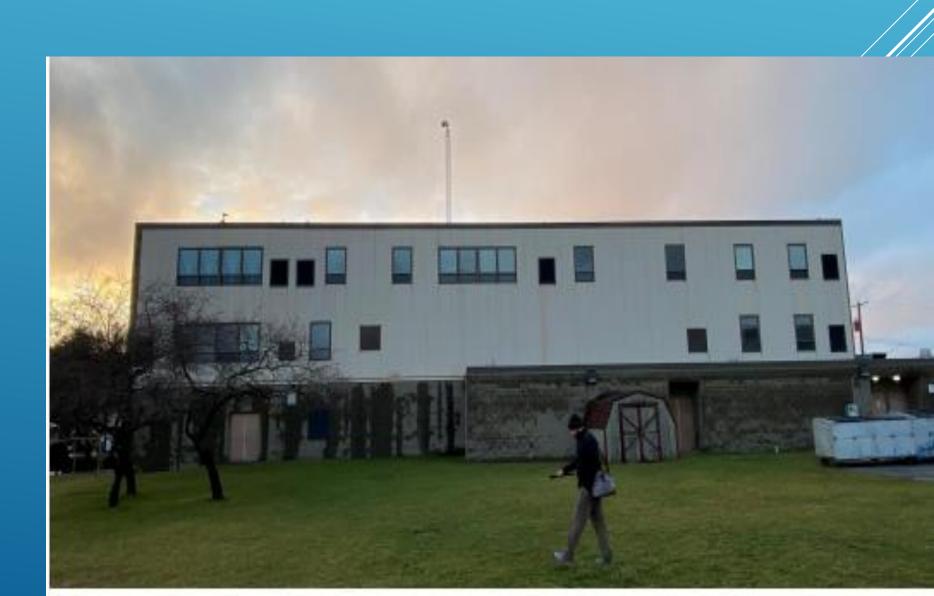
