## **ADMINISTRATOR'S REPORT**

Katlin Little, Athletic Director, shared highlights from the Athletic Department with the Board of Directors that included fall sports, 5g T-Mobile giveaway, online platform, and upcoming events.

Ms. Little began by thanking the board members and administration for giving her the opportunity to serve as the Athletic Director at Penn Cambria. It has been a fun Extending her appreciation to Mr. Hartline, Mr. Watt, Mr. Harrold, Mrs. Blackburn, Scott Sherry, Jackie Mento, and Mrs. Francisco.

Katlin continued with Fall sport highlights that included: boys soccer team placing 2<sup>nd</sup> in the District VI Championship; girls' volleyball securing their 1<sup>st</sup> playoff win in four years and ending with a 11-7 regular season record; football winning Laurel Highlands Athletic Conference for the first time since 1989, securing their first and second state playoff wins, and ending the season as a PIAA 3A Final Four finalist with a record of 14-1; Gavin Harrold and Preston Farabaugh receiving All-State Honors in football; Gavin Harrold winning Player of the year for the Altoona Mirror and Tribune Democrat; Coach Felus receiving two major awards as well - Coach of the year for both Altoona Mirror and Tribune Democrat; and Gavin Harrold and Marcus Eckenrode being named to PFN Class 3A All-State Football Team.

Ms. Little also expressed her pride for the community for their involvement and dedication in the 5g T-Mobile giveaway, where Penn Cambria School District advanced through the first round and won five thousand dollars. This competition was a win-win situation, it brought the community together and made Ms. Little immensely proud of the community's dedication and hard work.

This coming spring, the athletic department will launch an online platform called Student Central through Big teams, to be made active next Fall 2025. The platform will contain sport physicals, paperwork, and all the forms that are needed for student athletes. It will be an adjustment at first, however, it will be beneficial in the long run.

This week is Officials Appreciate Week, where officials will be recognized through special announcements, gifts, etc. in order to thank them for their incredible work and dedication. Also scheduled this week is Teacher appreciation night that will take place at Friday night's boys' and girls' basketball double header against Bishop Guilfoyle.
